# Strategy overview



The portfolio combines complementary algorithmic approaches designed to capture persistent inefficiencies across highly liquid global markets. One set of strategies targets momentum opportunities in major currency pairs, while another focuses on breakout dynamics in gold. Additional systematic signals, including short-term seasonal patterns, are applied to enhance overall diversification. Investors can allocate through our partner broker or via custom structures.
